### MONTICELLO – OUR NEWEST

Editor note: we're leading off the year with a profile of chapters; you'll learn more about the KSSSAR chapters in future issues as each chapter steps forward and takes a bow.

The roots of the newest chapter in northwest Johnson County can be traced to the father of most Kansas City area chapters -- Delaware Crossing. In June 2006, DX took a huge step and set up an outreach booth at Old Shawnee Days. For years, the Color Guard had been in the annual parade, and it was time to do something at the end of the march up Nieman Road. This was a chance to tell the public about the patriotic group which led the parade.

Over 100,000 people passed through the gates during the two-day event. A number of people signed up to learn more about the SAR and to attend a genealogy workshop. During a follow-up workshop, prospects started asking about a chapter in northwest Johnson County and, eventually, the Shawnee-Lenexa area, where the population in this area exceeds 100,000. An organizing petition was signed which resulted in the granting of a charter in November 2006. The first official meeting took place in December 2006, and Paul Whatley was elected president.

The chapter took its name based on a key road in the western part of the area -- Monticello. This represents a strong connection between the local area and Thomas Jefferson's home.

2007 will be remembered as a boom year for the chapter. The membership count started with 13 members in January and ended the year with 33 compatriots. (Minimal renewal loss for 2008.) Other "firsts" during the year include Eagle Scout essay winner, Law Enforcement, Fire Safety, web page, and a beginning with the Americanism poster contest. The chapter celebrated the first anniversary with a formal dinner and an induction of six new compatriots. The chapter has a newsletter, and email is the primary means of distribution.

#### WHAT DOES THE SAR DO?

The Sons of the American Revolution is a patriotic, historical, and educational organization. The stated purpose at <a href="www.sar.org">www.sar.org</a> refers to patriotism, institutions of freedom, and national symbols to name a few. But what does that mean? How does one execute this purpose as an individual, a chapter or a state society?

We have available a guideline of what can be done to fulfill the purposes of the SAR. It is found through the SAR's Americanism Award. The beauty of the Americanism Award program is the listing of numerous activities that a chapter and this state Society may carry out to fulfill the purposes of the organization. Examples of activities include: promoting the meaning of the American Revolution through various youth programs, working with Veteran-related endeavors, helping with public relations, to name a few.

The Americanism Award program is a beginning, a framework if you will, of what a compatriot or chapter can perform to fulfill the mission of the SAR. After you read the list of activities, you'll be better prepared to answer that question of what the SAR does. Plus, you can answer the question, "what can I do?"

It is a new year and a chance to do more in the SAR. Membership in this Society brings an honor and the weight of an obligation to remember our ancestors. To paraphrase George Bernanos: we can think a lot about doing things, but if those thoughts don't result in action, then we have nothing. What can you do to make a difference in 2008?

The chapter meets on the third Thursday of the month at 6:00 PM, twelve times a year. An executive committee meeting takes place one week in advance. The evening meeting time is attractive for many men, and spouses do attend. The dues are \$13, and a number of men have contributed extra funds for special programs.

The chapter leadership is comprised of men across a spectrum of experiences and ages. **David Comer** was elected president in November 2007 and brought a wealth of experience as state Treasurer along with his years in DX. Other officers include Executive VP **Jeff Walsh** (the traveling man); Secretary **Lee Crutchfield**, who brings lots of administrative experience from another organization; VP Programs **Gene Amos**, which is a role he did splendidly for DX; and **Barney Ellis** as the chapter mentor. There are also a number of supporting cast in the chapter.

#### **AMERICANISM 2008**

You may have heard of the Americanism Program and wondered how it could work in my chapter. What are the steps to start or enhance what we are doing? First, remember the Americanism Program is simply a tool to gain recognition for each chapter and the Kansas State Society for all the fine work already accomplished by each chapter and the state society, no more and no less. Obviously every chapter already performs many of the fine activities for the benefit of our youth and veterans, so lets gain the recognition so richly deserved.

Any question about the Americanism programs can be easily answered by referring to the National SAR web site at www.sar.org and selecting the tab "For Members", then "National Committees", and "Americanism". Or you can contact the state chairman, Keith F. Lindgren, who is available to help in any way. The Americanism score sheet is the tool to use to report your chapter's points each month to the Americanism state chairman.

For those chapters who haven't yet appointed a chapter chairman for Americanism, please do so as soon as possible and inform the state chairman.

Following are some key areas every chapter can participate in as part of the Americanism Program.

- 1. A chapter web site is 100 points a year. A great place to start is www.freeservers.com. For about \$2.00 a month, plus a \$9.95 domain charge, you can use all their tools to setup and maintain your site including templates to make setup very simple. You can review the Konza Prairie site at www.kpksssar.org. Most every chapter has a computer savvy compatriot who can do this. Contact the state chairman if help is needed.
- 2. Newspaper or periodical publicity in commercial publications is 50 points for each article. If each chapter would submit one article a month recapping their last month's activities to their local newspaper, it would equal 600 points for the year and, more importantly, would publicize the activities of the SAR, attracting more members.
- 3. American Revolution presentations to fifth grade elementary classes are 10 points for each presentation. One of the most important programs the SAR offers is to educate our children about their wonderful heritage in a hands-on manner. The related picture shows Konza Prairie Chapter President Gary Groh and compatriot Cliff Meloan leading a presentation to a class of fifth graders. They gave their presentation to 25 fifth-grade classes during 2007 including demonstrations of their period muskets. The muskets were a big hit with the children, and the presentations were well accepted by both the students and teachers.
- 4. Youth Programs, the foundation of all SAR activities, which educate our children, are 25 points each. There are the Knight Essay contest, Eagle Scout Essay contest, Rumbaugh Oration contest, ROTC/JRROTC Cadet Recipient, and the Poster contest.
- 5. Awards and Recognitions to non-members are 15 points each. There are the Good Citizenship Medal, Law Enforcement Medal, Fire Safety Medal, Heroism Medal, R.O.T.C. Medal, Service to Veterans Medal (Non-SAR Member), SAR Appreciation Medal (DAR Members), and Martha Washington Medal

These are just a few of the activities contained in the Americanism program. They are activities in which all chapters can participate, no matter how small the chapter. Certainly few (if any) chapters can do them all, but each chapter can choose those activities they feel most important to their compatriots and give them every effort possible.

If we all pull together, Kansas can win the National Americanism contest. Every member has good ideas, we just need to give them the opportunity to express and activate those ideas. It is with all sincerity that your help and direction and support is requested.

#### THE LIBERTY BELL - Mike Frisbie

700 newsletters were printed at a cost of \$506.74. 688 newsletters were mailed from the Shawnee Mission Post Office on October 29. The cost of mailing was \$107.89, of which \$34.40 was covered using pre-cancelled postage and the remaining \$73.49 was covered by the Society's post office account, leaving a balance of \$260.65. Last minute, post-print corrections were required by the post office at mailing time. One correction is in regards to the use of "address correction requested" that is printed with the return address. The post office no longer accepts this phrase, which required it to be removed manually. This phrase will be replaced in forthcoming editions with the acceptable "return service requested" that direct undeliverable mail to the return address. The other correction is in regards to the permit number. This was manually corrected by using pre-cancelled postage to fix the problem.

A different printer was used to shorten the turn-around time in publishing the newsletter; however, the resulting product was of inferior quality, so a return to the previous printer is planned.
