Speaking of the next generation, there have been many new younger members and leaders of the Kansas Society. A path must be created for these younger Compatriots to advance into areas of service in their chapters and the State Society. Each chapter develop encouraged to а mentorship program to train educate and new Compatriots so that they will take an active role in our chapters, our State Society, and in the National Society. Over the next several months, I will publish a mentorship guide in the Liberty Bell and make a Power Point presentation available.

Finally, I challenge every chapter in the Kansas Society to develop a chapter Color Guard. 2021 USS Stark Memorial Awards

In 1988, the National Society Sons of the American Revolution (NSSAR) established the USS Stark Memorial Award program "to memorialize those brave men and women who continue to stand at the forefront to preserve the freedoms our patriotic ancestors fought so long and hard to achieve."

The NSSAR USS Stark Memorial Award program recognizes outstanding chapters for their direct support of veterans. The NSSSAR Veterans Committee establishes the criteria for the USS Stark Report annually and adjusted the 2020 report to allow virtual participation at events due to the COVID-19 Pandemic.

It is important to highlight the USS Stark, which was a United States Navy guided-missile frigate launched on May 30, 1980. On May 17, 1987, during a deployment to the Middle East it was struck by two Exocet missiles fired from an Iraqi warplane. There were thirty-seven United States Navy Sailors killed and twenty-one injured. The Stark was repaired and returned to service but was later decommissioned in 1999.

The reporting period for the USS Stark Award competition is January 1 through December 31 of each year. Chapter activities are recorded by each Chapter, typically the Chapter Secretary who also serves as the Veterans Committee Chair, using that year's specific scoring sheet. As the title of this article highlights, 2020 was a banner year for the Kansas Society's efforts in supporting veterans and honoring those who have passed

The NSSAR awards recognize by ranking the chapters and state submissions. The categories for chapters are: 1 to 49; 50 to 99; 100 to 199; and over 200 members. State categories include state societies with less than 1,000 and with more than 1,000 members. Judging is conducted by using the average points per registered member of the chapter and society. It

should be mentioned that first place winning chapters and state societies cannot receive the award for two consecutive years. A "Honorable Mention" category exist for chapters and state societies who fall in the Honorable Mention category, which also comes with a streamer for consecutive first-place finishers at the NSSAR level.



Congratulations to all the participants in the 2020 USS Stark competition. The KSSSAR was the winner of the 1000+ category for 2020. The Georgia Society had more points, but they won in 2019 and cannot win again until 2021. The KSSSAR was the only State Society that had one hundred percent of their chapters submitting reports, but not all chapters had points associated with their reports, which was requested by the NSSAR Veterans Committee who oversees the USS Stark program.

Chapters who submitted their activities for the 2020 USS Stark competition where extremely successful in honoring and supporting veterans to include:

Bennington Chapter ranked #26 for chapters 10-49 members.

Charles Robinson Chapter ranked #30 for chapters 10-49 members.

Delaware Crossing Chapter ranked #16 for chapters 100-199 members

Henry Leavenworth Chapter ranked #3 for chapters 100-199 members.

Monticello Chapter received Honorable Mention for chapters 50 – 99 members. The chapter had the most points for the category but cannot win again until 2022 since they came in #1 in 2019.

Sons of the Plains Chapter ranked #22 for chapters 50 – 99 members.

Prairie Minutemen Chapter ranked #31 for chapters 10-49 members.

Washington Chapter ranked #20 for chapters 100-199 members.

An important part of the USS Stark Award program includes recognizing individuals who support Veterans and the program. The Service to Veterans Medal may be awarded to SAR members who have given long and exemplary service to



veterans. The medal is awarded for 5000 USS Stark Award points accrued by a SAR member in good standing. The medal is to be awarded by the Chapter. It is important to know that documented points can be accumulated and held locally at the Chapter over several years until points are accumulated to receive the medal or an Oak Leaf Cluster (OLC). The Bronze OLC will be awarded for each multiple of 3,000 points earned after the first award.

Compatriot Ron Sisk of the Monticello Chapter once again led in the accumulation of points for the

Kansas Society qualifying for 8 Oak Leaf Clusters to his Service to Veterans Medal in 2020. His support of the Veterans Community Project of Kansas City, Missouri is inspirational and continues into 2021.

The 2021 USS Stark Report Scoresheet has been released and distributed to each chapter President. The NSSAR committee has continued to allow virtual participation of certain events due to the continuation of the COVID-19 Pandemic.

The 2021 report will be the first time that we will have individuals who volunteered to be representatives at one of three Department of Veterans Affairs (VA) Medical Centers in the State of Kansas! These individuals were nominated by the NSSAR Veterans Committee Chairman and accepted by the VA Medical Center Volunteer Coordinator, At the Robert J. Dole VA Medical Center in Wichita, we have Compatriots R. Matthew Joyce (WA) and Ron Upton (WA); at the Colmery-O'Neil VA Medical Center in Topeka we have Compatriots Richard H. "Dick" Tinder (CR), Jim Cooper (CR) and James Long (WA); an at the Dwight D. Eisenhower VA Medical Center in Leavenworth we have Walter Schley, Jr. (HL), Kirk Rush (DX), and Bryan Wampler (MC). The KSSSAR can have more appointed representatives at the Kansas VA Medical Centers, or other Medical Centers in other States. Membership Development

Let us return to the discussion Ωf member development (mentoring). Member development is the transition of the new members consistently involved into members in their local chapters. This includes attendance at chapter meetings, participation in chapter events, and assistance in chapter programs. Ultimately, it means having new members move into chapter leadership by serving on a committee or as a chapter officer. I was recently on a Zoom call for a National committee and listened to a few members lamenting that member development is a perennial concern. That is nearly always true about volunteer organizations and this means we must continually address this issue. I would like to offer some suggestions for member development in this and future articles in the Liberty Bell.

As a pastor of a local church, I have been in a leadership position in a volunteer organization for over forty years and I have applied a successful strategy for member growth and development that I learned some years ago. In seeking for the growth of Kansas Society, I propose this three-fold strategy to our chapters. The three-fold includes strategy content. relationships, and service. I have illustrated this by calling this the three-legged stool. These three components should be kept in balance and can lead to a substantial the arowth in

personal attachment of members to their chapters.

The first component is with content. As any organization, there is a quantity of information that must be communicated to the members at all levels of the organization: chapter, state, and national. This includes a number of areas, such the history the as, obiectives. and organization. specific distinctives that are characteristic of each level. For new members we should identify the chapter officers and their functions as well as the various committees and what they do. We should identify the three overall objectives of the Sons of the American Revolution, which are: historical, patriotic, and educational; and explain how the chapter puts these into practice.

The second component is relationships. Studies show that the greater the relationships between the members of a chapter, the greater will be the cohesion to the chapter. For this we must develop relationships with other chapter members, from arowing casual acquaintances to closer friendships. Our patriot ancestors served in small units developed a strong camaraderie with those with whom they served. Often, the friendships they made during their military service lasted a lifetime. We should work at developing stronger relationships among our chapter members by learning and remembering their names. occupations, unique skills, and

what they enjoy about the Sons of the American Revolution. We all have something in common: we all have ancestors who served courageously in the American Revolution. From that common ground can grow significant friendships.

The third component is service. Quite frequently, we grow in our friendships by serving together on projects and events. The Kansas Society of the Sons of the American Revolution offers a wide variety of projects and events to enable our compatriots to serve together. We have chapter meetings, Color Guard events, youth programs, and educational programs that are designed to give everyone the opportunity to serve by doing something that will make a difference in the lives of others.

We want everyone to be involved. Recognition of our family's heritage as descendants of Revolutionary War patriots is probably why most of us joined Sons of the American Revolution. We are proud of our ancestors and patriot country. Beyond this, we want you to actively participate and support our Society's objectives of patriotism, education, and history. Let us welcome our new members and help them become in our chapter, state, national SAR, and patriotic community activities. The 129th State Conference kicked off with the colorguard presenting the colors.




Book Review

Washington: A Life by Ron Chernow

Soon after became a member of the Henry Leavenworth chapter, then Chapter President Brooks Lyles invited our chapter to the Kansas City Public Library to listen to a presentation on George Washington by author Ron Chernow. Since George Washington plays such a prominent role in the Sons of the American Revolution.



attended this event with other members of our chapter. Mr. Chernow had recently published the book *Washington: A Life*. After his presentation, I purchased Mr. Chernow's book and found that he is a good writer and a careful historian. He divides Washington's life into six chronological sections he entitled "The Frontiersman," "The Planter," "The General," "The Stateman," "The President," and, "The Legend." The book has sixty-seven chapters and over eight hundred pages of biographical text.

I was particularly moved by Washington's surprise at being elected the Commanding General of the Continental Army. Chernow writes, "In accepting this appointment, Washington was haunted by the uncertain fate of his wife, who would be left alone and might become the target of British raids. For three days Washington couldn't bring himself to write to her. Then on June 18 he sat down with trepidation to inform her of his extraordinary appointment: "My Dearest, I am now set down to write you on a subject which fills me with inexpressible concern and this concern is greatly aggravated and increased when I reflect on the uneasiness I know it will give you...You may believe me...when I assure you in the most solemn manner that, so far from seeking this appointment, I have used every endeavor in my power to avoid it, not only from my unwillingness to part with you and the family, but from a consciousness of its being a trust too great for my capacity...it has been a kind of destiny that has thrown me upon this service...it was utterly out of my power to refuse this appointment without exposing my character to such censures as would have reflected dishonor upon myself and given pain to my friends."


I recommend this book to you and urge you to read it. It was published in 2010 by New York's Penguin Press and is likely available at your local public library and on Amazon.




Bobbie Hulse and Larry Stevens display the SAR 250 flag at the state conference

State Brochure Contest Winner



Americanism Report

The 2020 Kansas report was filed by March 1, 2021. In the Americanism contest, Kansas reported 17,660 points compared to 21,544 for 2019. In the President General Streamer contest, Kansas reported 24,469 points compared to 18,515 points for 2019. Combined totals were 42,229 points for 2020 compared to 40,059 for 2019, despite Covid 19 restrictions for almost nine months in 2020.

Americanism recognizes chapters and states that participate in outreach education efforts and who acknowledge community leaders for their efforts to perpetuate the goals of the SAR. The President General's Streamer contest recognizes chapters and states for their efforts to achieve the

administrative goals of the SAR and who contribute to the success of the SAR.

Seven chapters filed Americanism reports for 2020. Special thanks to Bennington, Delaware Crossing, Henry Leavenworth, Monticello, Sons of the Plains, Washington and our new chapter, Prairie Minutemen. Chapter Americanism reports along with state activities are combined to complete the Kansas Americanism report.

The winners of the 2020 contests will be announced at SAR Congress in July and the release of individual chapter and state results in the fall of 2021.

My Ancestor Search

In 1998, I began my search for my longforgotten ancestors. My search officially began in 1989 during a family reunion in Fayetteville, Tennessee, and even at that time the War Between the States still carried memories from the old timers that were alive at the end of the last remaining veterans.

In 1999, I returned to Fayetteville to visit my great grand uncle, who was now 90. My search for the Fanning Cemetery was in need of his memory to aid me in my quest.

I found it just like he said, 6 dry creek beds down Kelso Road, on the left stands a large Oak in a pasture and there it was. In 2004 with the help of the Rome, Georgia SCV, we marked my SCV ancestor (G3) who was buried in the family cemetery along with my G4 and G2 and many others. But my search had just begun. Where to go from here? More research would bring my search to the newly Charter Monticello Chapter and with the help of my sponsor, Tim Peterman, the documentation started in 2008.

My official date of admission was March 30, 2010. Lt. Laughlin Fanning was my Patriot ancestor, my direct ancestor, my 6th Great Grandfather.

The search for his grave was by this time marked by Georgia SAR in 2008. Due to my work schedule, a visit would not take place for quite some time.

I travel for work and take advantage of the time working in different places for my ancestry research or historical visits. In 2018 I was working in Fayetteville, North Carolina and went to visit the Alston House or better known as the House in the Horseshoe.



Phillip Alston is another Patriot Ancestor, my G6 and the antagonizer, a Loyalist, Colonel David Fanning was the nephew of Lt. Laughlin Fanning. In 2018, I was approved for admission to The Loyalist and Patriots Society thru Lt. Laughlin Fanning and Col. David Fanning. Also, in 2018 I was approved to The First Families of Missouri and the SUV of Missouri. These early Missouri pioneers followed Daniel Boone from Virginia, Kentucky, and Missouri. Several were War of 1812 Veterans. In 2015, I joined the Missouri Chapter War of 1812.

The home of my 4th Great Grand Uncle, the Hickman House, sits in Columbia, Missouri at the University of Missouri Ag Farm. My early ancestors Hickman, Moss, and Brown donated land which later became The University of Missouri.



My search to prove my ancestors does not stop. Thru documentation, I have been successful in my quest. In 2018, in North Carolina, I visited 2 Patriot ancestors in South Carolina. One in Society Hill and another nearby. Yesterday I finally was close enough to drive and find my 6th Great Grandfather, Lt. Laughlin Fannin. With the help of Find a Grave, a couple of old timers, and a 300-foot hike thru the Georgia brush, I found him.



My journey does not end here. It will continue, not because I collect certificates, but to bring these ancestors back and honor them.

I want to thank Tim Peterman for that spark that began in 2008.

On March 20, 2021, at the Kansas Society Annual Conference in Leavenworth Kansas, the members present approved the updated Kansas Society Handbooks. The Handbooks contain the governing documents and official policies, procedures, and protocol of the Kansas Society of the Sons of the American Revolution. It provides official guidance at the Kansas Society and Chapter levels on the operations, programs, and activities of the Kansas Society. Compatriots of the Kansas Society should regularly review the Handbooks.

The Kansas Society Handbooks come in two volumes consisting of Volume I, Constitution and Bylaws. Volume I Part I contains the Constitution and Part II contains the Bylaws. Handbook Volume II contains the Processing Instructions

and Administration for the Kansas Society with Part III containing the Processing Instructions and Part IV containing Administration instructions.

Updates for all sections were provided by Board of Governor members to include the different committee chairs. Other recommended changes were provided by members from throughout the Kansas Society. It is believed that having different elements of the Kansas Society contained in multiple handbooks will allow for ease of use and ease of updating when the need arises.


